

PETITION TO PLACE INITIATIVE NO. MSLA2006-01 ON THE ELECTION BALLOT

CITY INITIATIVE NO. MSLA2006-01 TO HALT CONSTRUCTION OF THE THREE-LANE MOTOR VEHICLE CONFIGURATION ON WEST BROADWAY AND TO CONSTRUCT AN ENHANCED FOUR-LANE ROAD INSTEAD. THIS INITIATIVE PROPOSES THAT THE QUESTION BE SUBMITTED AT A SPECIAL ELECTION.

If 25% of the voters in the City of Missoula sign this Petition and the total number of voters signing is 12,475, this measure will appear on a special election ballot.

We, the undersigned voters, propose that the County Election Administrator place the following measure on the ballot at a special election that is at least twenty-five (25) days after the adequacy of the Petition is determined by the Election Administrator, as required by State law.

Statement of Purpose:

The city elector initiative proposes to halt the construction of a West Broadway three-lane motor vehicle traffic lane configuration on West Broadway between North Russell Street and Orange Street (known as the "Broadway Diet") and to construct an enhanced four-lane road instead. "Enhanced" to mean more street lighting, a traffic light at or near Burton Street to facilitate safe pedestrian crossings on West Broadway, left-turn lanes, identifiable pedestrian crossings, reduced speed limit and cautionary signals, all to meet or exceed Montana Department of Transportation (MDOT), State of Montana and Federal standards.

Voters are urged to read the complete text of the measure which appears above. A signature on this petition is only to put the measure on the ballot and does not necessarily mean a signer agrees with the measure.

This Petition was first circulated on **May 15, 2006** and all signatures must be collected within ninety (90) days.

A person who purposefully signs a name other than his/her own to this Petition or who signs more than once for the same issue at one election or signs when not a legally registered City voter is subject to a \$500 fine, six months in jail, or both. Each person must sign his/her name and address in substantially the same manner as on his/her voter registry card or the signature will not be counted.
