Downtown Gift Cards: Good for Business & Consumers

As the holidays arrive, the Missoula Downtown Association wants to ensure members and downtown customers are fully informed on the benefits of the Missoula Downtown Gift Card program.

Due to a variety of problems and the desire to grow the program for our members, the MDA switched from paper to plastic in the fall of 2009. Prior to conversion, consumers were depositing the paper certificates into their bank accounts, making small purchases and pocketing the cash balance, using the paper program to pay utility bills, and redeeming the certificates at non-member businesses. Redemption rates hovered around 75%.

Converting to a closed credit card system improved utilization at MDA member businesses only; improved financial tracking of purchases and

redemptions; increased overall growth in sales and redemptions; reduced confusion at the point redemption; and improved the overall customer and member business experience.

Since implementation, Downtown Gift Card sales have increased by 125% percent, and last year's redemption rate was 90%.

StoreFinancial, the MDA's contracted service provider, is also on contract with Southgate Mall, the Downtown Billings Partnership, the Downtown Boise Partnership and many other downtown organizations and shopping centers across the nation. In 2009, StoreFinancial was one of only three businesses that provided multi-merchant gift card programs and was, by far, the most recommended among the three.

disadvantage However, one to this program is the contractrequired inactivity fee of \$2.50 per month following 12 consecutive months of no activity on the card.

This can be avoided if the owner uses the gift card at least once every 12 months. MDA staff members work diligently to educate the consumers about the fee at the point of purchase, both orally and in writing on the plastic cards and on the packaging wrapped around the card.

Here are some other interesting facts you should know about the Downtown Gift Cards:

- Montana law does not allow for aift card expiration fees. However, multiple-merchant gift cards are exempted from this law (Section 30-14-102 (5)(b))
- Both consumers and merchants can verify the balance on any Downtown Gift Card via phone (800-755-0085) or online (www.getmybalance.com) in less than two minutes. This information is printed on the back of every card.

\$160,000 were redeemed at 165 MDA member businesses, an average of almost \$1,000 in additional sales per business, and the highest redemption rates

are greater than

\$6,000 per year.

The MDA works diligently to promote the program and educate the consumers about the Downtown Gift Card. Staff have responded to consumer and member suggestions, and efforts to draw attention to the inactivity fee now include notification of the fee in six different ways, including a "Use By" sticker on the front of the card.

While there may be drawbacks, the benefits of the Downtown Gift Card program far outweigh the disadvantages, and our goal is to continue to grow this benefit of membership that improves the downtown economy, supports Missoula's locally-owned businesses, and provides a great gift option for friends, family, employees and more. As always, the MDA welcomes questions and suggestions for improvements.





Think Outside the Box [stores]

As consumers, we're about to collectively spend a large portion of our annual shopping budget on holiday aifts. Have you ever considered where that money goes once it's out of your hands?

So many of us get caught up in the advertising blitz that surrounds Black Friday and Cyber Monday. But nestled in between is a quiet little event called Small Business Saturday. Although the 'holiday' is part of a national campaign to shop small, the Sustainable Business Council is happy to encourage it because shopping small invariably means shopping at locally-owned merchants—and buying local is a big part of building a thriving sustainable business environment.

When shoppers buy from locallyowned businesses, 30-60% of their dollars stay in the local economy, versus just 15% when buying from a chain or 'box store.' Buying Local ensures the success of our community, not only in promoting variety and local character, but in many other ways as well. For example, local businesses are more involved in their communities—financially and personally—than chain stores. Buying local often reduces energy use and carbon emissions, and allows shoppers to vote with their dollars to help make locally-produced goods successful.

In the past few years, the Buy Local movement has gained ground in Missoula and the surrounding areas, thanks in part to the efforts of the Sustainable Business Council. To help promote the Buy Local movement, SBC conducted a Buy Local Challenge contest in November, and is continuing the message with a Buy Local punch card and "Think Outside the Box [stores]" advertising. In addition, the SBC is working with the Mayor's office to have December declared as Buy Local month.
